



OPTIONS THAT WORK FOR YOU... NOT AGAINST YOU

We offer two training programs. Our **On-Site** program for students who can totally immerse themselves into our world at the West Barn and a **Distance Learning** option for students who prefer to learn in their own time and space.

ON-SITE

Students who choose our **On-Site** program will participate in two collaborative weekly group class/session in the studio focusing on the weeks discipline.

Classes will meet Tuesdays and Thursdays from 9 am to 4pm CST with a 1-hour break. Wednesdays students will have lab from 10am-1pm

Students will also have multiple opportunities to utilize the studio throughout the week. Including but not limited to participating and assisting with studio sessions and events. Part of the curriculum consist of customized real-world projects for each student based on their long-term career goals. There will be multiple opportunities to experience special guest lectures and workshops hosted by some of today's top music industry professionals.



DISTANCE LEARNING

This is not your typical online program. With the use of technology, we have created an interactive program for students who don't have the ability to pack up and relocate to Tennessee that is the closest thing to being here in person. This option will allow students to learn in their own home studio environment while interacting with their instructor and other students in a virtual space.

Students who choose our DISTANCE LEARNING program will also be able to participate in the collaborative weekly group classes/sessions in the studio focusing on the week's discipline. These classes will be accessible via live stream or through our video library and learning management system. Distance Learners will have weekly scheduled 1 1/2-hour one-on-one sessions devoted to the week's discipline. Each session will focus on the student's exact skill level. In addition to the one-on-one time, we recommended Distance Learners spend a minimum of 8 hours each week in their studio working on that week's assignment. Whenever possible Distance Learners are invited to participate and assist with studio sessions and scheduled events.

Part of the curriculum consists of customized real-world projects for each student based on their long-term career goals. There will also be multiple opportunities to experience special guest lectures and workshops hosted by some of today's top music industry professionals.

Distance Learners are required to have the following tools:

Applying students must submit an **official** copy of their high school transcripts, HSE diploma or GED before beginning classes. To be considered for enrollment you must have an admissions interview, fill out the admission application and submit your application fee. No students will be allowed to start classes after the official start date without approval from the Institutional Director.

Credentialing:

Apprentice Academy currently offers a Certificate of Completion upon the successful completion of coursework and testing.

Tuition, Fees, and Expenses:

Tuition for the **16-week ON-SITE** Audio Engineering/Music Production program is **\$11,750**. The application fee of \$250 is in addition to the tuition cost.

Tuition for the 16-week DISTANCE LEARNING Audio Engineering/Music Production program is \$8,750. The application fee of \$250 is in addition to the tuition cost.

Payment Options:

We offer several financing options for students who wish to take advantage of a payment plan while attending classes. Please ask your admissions representative for details.

Cancelation Refund Policies:

Students understand that they may terminate their enrollment at any time, according to the Refund Policy section. The student may also terminate enrollment if upon a doctor's order, if they cannot physically receive the services. If the student terminates enrollment for either of these reasons, Apprentice Academy may keep a portion of tuition as described in detail in the Refund Policies section less the application fee of two hundred and fifty dollars (\$250.00). The official date of termination will be determined by the last day of class as recorded in the daily attendance log. The student understands that they have up to one calendar year from the date of their original application fee to start classes without paying an additional application fee. Students understand that reassignment to an alternate class start is based on availability. Refunds requests must be submitted in writing to the Institutional Director and may take up to six weeks to process. A check will be mailed to the address that is provided in the written refund request.

Refund Policy:

- 1. If a student withdraws from the institution on or before the first day of class, or fails to begin classes, the refund shall equal the sum of all amounts paid or to be paid by or on behalf of the student for the period of enrollment, less the application fee of two hundred and fifty dollars (\$250.00)
- 2. If after classes have commenced and before expiration of ten percent (10%) of the period of enrollment for which he or she was charged, a student withdraws, drops out, is expelled, or otherwise fails to attend classes, the refund shall equal seventy-five percent (75%) of all amounts paid or to be paid by or on behalf of the student for the period, less the application fee of two hundred and fifty dollars (\$250.00) 3. If after expiration of the of ten percent (10%) of the period of enrollment for which he or she was charged, and before expiration of twenty-five percent (25%) of the period, a student withdraws, drops out, is expelled, or otherwise fails to attend classes, the refund shall equal twenty-five percent (25%) of all amounts paid or to be paid by or on behalf of the student for the period, less the
- 4. If after expiration of twenty-five (25%) of the period of enrollment for which he or she was charged, a student withdraws, drops out, is expelled, or otherwise fails to attend classes, the student may be deemed obligated for one hundred (100%) of the tuition, fees and other charges assessed by the institution.

Statement of Student Record Retention Program

Apprentice Academy maintains student transcripts indefinitely. Student files including academic and financial information are kept for at least ten years.

Attendance Policy:

Apprentice Academy is a highly intensive program. Failure to attend will negatively affect how much you get out of the course. If a student has extraordinary circumstances (i.e. death in family or illness), it is up to the student to notify the Director as soon as possible. If a student misses more than 25% of the program, he/she is subject to dismissal.

Student Conduct:

In the interest of efficient and safe operation, and to protect the well-being and rights of all students, it is necessary to observe certain rules of conduct. Students are expected to become familiar with these rules and observe them without exception. If any rules are unclear, please speak with someone from the Apprentice Academy team. Violation of rules is cause for disciplinary action and or expulsion.

The Rules of conduct are as follows:

- Students are expected to come to class prepared. Students must be on time for lectures, labs, classes and projects and participate and pass testing and other evaluative assessments and competencies throughout the program.
- 2. Students must not arrive for school under the influence of alcohol or illegal drugs, and cannot bring alcoholic beverages, illegal drugs or weapons of any kind onto the property.
- 3. The following actions may be cause for immediate dismissal:
- Committing a criminal act on or off AA property

- Carelessness or neglect resulting in abuse to equipment and tool
- Use of threatening, harassing or abusive language towards staff or fellow students
- Failure to cooperate in the investigation of accidents
- Any acts of dishonesty, lack of integrity or misrepresentation
- Representing Apprentice Academy in an unfavorable or unprofessional manner
- Failure to be considerate to the privacy of West Barn clients
- Not participating in class or taking direction from the instructor
- Cell phones must be turned off during class. No calls, texting, video recording or gaming without permission from your instructor
- Excessive Absences

Never give a client CD's, tapes or any projects in which you are working on without your instructor's knowledge. It is emphasized, however, that any act or omission, which in the judgment of management is not consistent with this policy, shall be grounds for disciplinary action or immediate dismissal.

Any covered individual will be able to attend or participate in the course of education during the period beginning on the date on which the individual provides to the educational institution a certificate of eligibility for entitlement to educational assistance under chapter 31 or 33 (a "certificate of eligibility" can also include a "Statement of Benefits" obtained from the Department of Veterans Affairs' (VA) website – eBenefits, or a VAF 28-1905 form for chapter 31 authorization purposes) and ending on the earlier of the following dates:

Grading and assessment:

Apprentice Academy follows Pass/Fail grading and assessment practices. An example of a Pass/Fail class is one where you either complete it successfully and get credit or you don't; but, either way, no grades are assigned. We feel we can better measure proficiency through the hands-on learning environment we provide, by keeping class size to a minimum, providing one-on-one learning and the daily monitoring and mentoring of the class with regard to equipment, software, hardware and various industry tools. Therefore final assessment will be a PASS or FAIL grade based on the oral, written and practical testing done throughout the program, weighing heavily on the final project. If a student is in jeopardy of failing the program they will be notified well in advance and throughout the duration of the program to have sufficient time to remedy the outcome. Students who fail the program will be allowed to return for another session. at their own cost.

Credit for Previous Training:

Apprentice Academy does not alter its core curriculum for any student despite prior training nor do we give credit towards our program for previous education. We will however work with each student individually to customize their training based on their personal level of experience.

Transferability of Credits:

Apprentice Academy is a special purpose institution. That purpose is to provide our students with a hands-on learning approach while providing the tools, strategies, and resources to excel in the music industry. Students should be aware that transfer of credit is always the responsibility of the receiving institution. Whether or not credits transfer is solely up to the receiving institution. Any student interested in transferring credit hours should check with the receiving institution directly to determine to what extent, if any, credit hours can be transferred.

Readmissions Policy:

Students who leave the Apprentice Academy in good standing may resume their studies by meeting with the Director to determine eligibility. Eligibility will be determined at the discretion of the Director. Students who have been dismissed from the Apprentice Academy and wish to resume their education should write a letter of appeal addressed to the Director and make an appointment for an interview. Any previous course work remains part of the permanent record for students who have been readmitted, and the cumulative average includes all prior grades, regardless of how much time elapsed between enrollment periods. Any balance of tuition must be paid prior to re-entry.

Student Grievance Policy:

If you have a complaint or problem you are encouraged to follow the Student Complaint Procedure, as follows:


- 1. You should discuss complaints with the individual(s) within the appropriate department. Initial discussion should be with the person most knowledgeable of the issues involved or with immediate decision-making responsibility.
- 2. If you feel that the complaint has not been fully addressed, a written account should be submitted to the Institutional Director of Apprentice Academy, Becki Sessions. The written account should indicate your name, phone number, and Student ID (SS#) and discuss the steps you have taken to remedy the situation. The address is 4526 Gosey Lane, Franklin, TN 37064.  3. The appropriate staff member or
- department will be notified of the complaint. A follow-up meeting with you and the Director will be held within ten school days of the date of the written complaint in an effort to resolve the issue.

 4. If you are not satisfied with the results, you may file an appeal with the Director.

 The appeal should be in writing and contain
- your name and phone number. You should summarize the steps you have taken to remedy the situation and indicate why the results are not satisfactory. You will hear the results of the appeal within ten class days from the date the appeal is received.
